Intended Learning Outcomes (ILO)

Upon completion of the course the student should have the:

Knowledge and understanding

- to identify and analyse the impact of common diseases/disabilities in a low- and middle-income context from different professional perspectives
- to identify and discuss cultural aspects and social determinants of health related to low- and middle-income countries
- to describe the relationships between poverty, disability, health care and welfare
- to discuss community based rehabilitation in relation to other rehabilitation models.

Skills and abilities

- to consider contextual factors and appropriate research methods while doing studies within a lowand middle-income country
- to access, identify and critically review published reports
- to explore local resources from a health care and welfare perspective
- to collaborate with different partners within the health care and welfare system.

Type of instruction

Study methods in this course are individual studies, lectures, group work and seminars.

The teaching is conducted in English.

Prerequisites

The requirement for entry into this course are passing grades of 30 Credits in any educational area.

The examination will be based on an individual written literature review which also will be reported verbally. Examination of judgement and approach will be based on an individual written reflection about the student's own cultural competence and the need for further development.
