General information about clinical placement in this course

This document concerns clinical placement in psychiatry in semester 4. Clinical placement in this course comprises at least 36 hours, which corresponds to 5 days performed during 1 week. The student is responsible for all pages in the assessment documentation being signed and scanned and uploaded as one document in the course's Canvas Room. This must be done no later than two weeks after completing VFU as a basis for course grades.

Psychiatric Nursing, 7.5 credits

Under supervision, the student will work on the basis of the nursing process with a focus on co-creative nursing in the short and long meeting with patients who have mental illness. It is an in-depth study compared with clinical placement in semester 3, that further focus is placed on being able to collaborate with people that the student meet in their future profession.

In case of problems during the clinical placement or in case of questions, the student contacts the Clinical Lecturer (KA) and the supervisor as well as the main supervisor who is connected to the placement. When there is a risk for a student not to achieve satisfactory results during clinical placement, KA and the main supervisor must be notified to, together with the student, plan for the remaining time in VFU.

Assessment criteria

Supervisor's assessment

In the clinical placement in psychiatry, the student's is assessed prior to a reflection seminar based on the points described below. The supervisor makes an assessment on page 1 if the student has satisfactory knowledge. Only after the supervisor has assessed satisfactorily can the student complete the final examination seminar (see Memorandum).

- ability to identify the need for nursing in the event of failing mental health, taking into account the patient's and their relatives' perspectives.
- demonstrate such professional proficiency that no person's health or safety are prejudiced.
- ability to problematize the consequences of co-creative nursing in relation to failing mental health.

Assessment at the final exam seminar

At the final examination seminar, the student is assessed based on the students ability to

- actively present the task based on the task's description in the Memorandum.
- orally reflect on how one's own approach and the care environment affects the meeting with the patient and their relatives.
- reflect on the dilemmas that can arise in nursing in connection with failing mental health and stigmatization in connection with failing mental health.

Attendance report
